III. Presentation: Adopt a Roadway program, Clyde Gallantine

- Business/org/individuals can adopt a minimum of 2 miles of roadway
- Entities are provided grabbers, badges, trash bags
- Signage indicating the cleanup sponsor and length of road sponsorship for entities that wish to participate
- Cleanup crew can coordinate with TPW to dispose of garbage or use their own bins
- Once meetings with all supervisors are complete, TPW will post the program info on the website
- Clyde estimates that the budget is about \$15-20K for the program, which is expected to grow; the signs are the most expensive part of the program

LTF was established under AB 939 as a Brown Act Committee. CalRecycle has decided not to renew/strengthen LTF responsibilities through SB 1383. Joey suggests merging LTF and ZWTF groups. Celia notes the overlap of people in both groups. Sunny in favor of merging the groups. Liz and Sunny discuss bringing options to next ZWTF meeting so that groups meet in alternating months, minimizing the number of total meetings. Stu notes the differences between groups and mentions that LTF is a statutory body whereas ZWTF is an ad hoc committee without the Brown Act requirements.

Terry Taylor would like to focus on film plastic recycling this year.

Stu brings up the situation with treated wood waste. Beginning January 1, 2021, it is no longer accepted at Central Landfill – or any landfill in CA unless it is classified as a Hazardous Waste LF. Disposal is now much more expensive as it can only go to Buttonwillow Facility over 200 miles away. Pacific Sanitation in Windsor has applied for a variance to accept the material and is waiting for approval.
