- Greg moved to approve Liz as the interim chair, Will seconded
- Passes unanimously

## IV. Selection of LTF Interim Secretary

- Sloane volunteered
- Liz motioned for Sloane to be LTF note taker for the next two meetings, Will seconded
- Passes unanimously

## V. Update and Vote on 5-year ColWMP Review

- Greg has small addition "LTF recommended and ZWS approved" wherever language currently says "LTF recommended"
- Liz and Stu said the document accurately reflected changes requested by the LTF
- Greg motioned to approve document with amendments mentioned, Stu Seconded
- Passes unanimously

#### VII. Discussion and Update of Clean River Alliance Issues

- Chris Brokate spoke about:
  - Mowing trash and creating microplastics in our waterways (CalTrans, City of SR, The County of Sonoma)
  - Johannes Hoevertsz presented an Adopt-a-Highway program to the Board of Supervisors
  - River Rd. and Hwy 116 to Jenner, road sections have been mowed and there was no trash mitigation there whatsoever; Guerneville Rd. is problematic, Santa Rosa Creek needs attention
  - Virtually no storm drain trash mitigation and no trash cleanup ahead of the mowing;
     COVID has derailed any trash mitigation that was happening
  - Trash program on main stem of the river with homeless folks cleaning up to 2000-3000 pounds of trash weekly
  - Tarp law not being enforced at the Transfer Stations
  - Contingency plan needed for material management when homeless are asked to vacate an area

### VIII. Legislative Committee Report

- Liz gave the update that AB 793 passed and was signed into law by Governor Newsom. This will require companies that produce single-use beverages will be required to use a minimum of 15% post-consumer recycled content by 2022, 25% by 2025, and 50% by 2030.
- SB 54 / AB 1080 did not pass, but it might come back in the next legislative session
- Will Bakx said that CAW is working with BPI on a new bill focused on labeling in California which
  will require that by a certain year, 25% of facilities will be required to accept compostable
  plastics, which would increase after a period of time. Under this proposed legislation, CalReycle
  will determine which facilities are required to accept the material. This labeling bill requires
  compostable products to be PFAS free, and as of January 1, 2020 all BPI certified compostable
  products must be PFAS free.
