# III. Proposal of an Amendment to the County Non-Disposal Facility Element (NDFE)

- Recology update from the Environmental Manager
- No capital expense except some repaving and other expenses, they would need to increase staff, increase in recycling rates
- The material currently going that they are trying to make availability for- it is just a transfer station before it is sent to a recycling center. Most of it is taken to the recycling facility in Santa Rosa and San Jose.
- Proposal to tons per day at the Petaluma BLV South Recology Marin increased to 220 tons per day accepted.

### IV. SB 1383 (Local Assistance Grant, Compost Events, etc.), Xinci Tan

- Cal recycle released an application for this grant for the jurisdiction to use in implementation.
- Money has yet to come down, but ideally this will be approved by April

- Cal Recycle will need to know if there are any amendments to the proposed budgets in advance.
- Upcoming composting events throughout Sonoma County TBD.

## V. Zero Waste Week, Leslie Lukacs

- Zero waste week will be in the last week of July.
- Collaboration and scheduling events with partners- movie screenings, trash and fashion show, compost training, Hugo doing Spanish outreach, Community Bikes will hold an event or class.

  - Stu- Would be great to get information about which would look great for what resources we can direct people to. Time would need to be spend on research in order to make those recommendations.
