ITEM: Resolution No. 2022-15, Making Findings and Determinations Under AB 361 for the Continuation of Virtual Meetings

I. RECOMMENDED ACTION / ALTERNATIVES TO RECOMMENDATION

Staff recommends that the Board adopt Resolution No. 2022-15, making findings and determinations under AB 361 for the continuation of virtual meetings.

II. BACKGROUND

On March 17, 2020, in the face of the COVID-19 pandemic, Governor Gavin Newsom issued Executive Order N-29-20 suspending certain provisions of the Ralph M. Brown Act in order to allow for local legislative bodies to conduct their meetings completely telephonically or by other electronic means.

The provisions in the Brown Act that were suspended by the Governor's Executive Order are contained in Government Code Section 54953(b)(3) and require that when teleconferencing is used, outside of a statewide emergency, that the following occur:

- An agenda is required to be posted at all locations, including any teleconference locations
- Each teleconference location must be identified on the actual agenda
- Each teleconference location shall be accessible to the public
- A quorum of the legislative body must be in the jurisdiction

With the Governor's Executive Order, the four above requirements were suspended, allowing councilmembers to not have to post an agenda at their teleconference location, not have to identify their location on the meeting agenda, not have to ensure public accessibility at the teleconference location, and the legislative body did not need a quorum in the jurisdiction. As the Board is aware, this allowed the Board meetings to be conducted by Zoom with Board members, staff, and the public all joining from remote locations.

The suspension of certain provisions of the Brown Act was further extended by the Governor on June 11, 2021 by the issuance of Executive Order N-08-21, which continued to allow for complete virtual meetings until September 30, 2021.

On September 16, 2021, the Governor signed AB 361, which allows legislative bodies to meet virtually provided there is a state of emergency declared by the Governor, and either (1) state or local officials have imposed or recommended measures to promote social distancing; or (2) the legislative body determines by majority vote that meeting in person

would present imminent risks to the health and safety of attendees. As a result, if Zero Waste Sonoma desires to have virtual meetings on or after October 1, 2021, it must do so consistent with the requirements of AB 361.

III. DISCUSSION

AB 361 preserves many of the provisions of the earlier executive orders, including the suspension of the four teleconferencing requirements noted above, while also adding new requirements to the management of remote and teleconference public meetings in order to better achieve the levels of transparency that the Brown Act demands. Specifically, AB 361 imposes two new rules on remote public meetings:

- 1. Local governments and agencies hosting teleconference meetings in lieu of traditional in-person public meetings must permit direct public comment during the teleconference, and must leave open the opportunity for public comment until the comment period for a given item is closed during the ordinary course of the meeting. The opportunity to make public comment must be of a sufficient duration so as to allow actual public participation. Zero Waste Sonoma already complies with this requirement, so it presents no change to our current practice.
- 2. Any action by the governing body during a public teleconference meeting must occur while the agency is actively and successfully broadcasting to members of the public through a call-in option or an internet-based service option. If a technical disruption within the agency's control prevents members of the public from either viewing the meeting of the public agency, or prevents members of the public from offering public comment, the agency must cease all action on the meeting agenda until the disruption ends and the broadcast is restored. Action taken during an agency-caused disruption may be challenged as a violation of the Brown Act.

In order to continue to qualify for AB 361's waiver of in-person meeting requirements, the Board must, within thirty (30) days of its first meeting under AB 361, and every thirty (30) days thereafter, make findings that (a) state or local officials recommend measures to promote social distancing, or that (b) an in-person meeting would constitute an imminent risk to the safety of attendees. State officials at Cal-OSHA have, through the adoption of certain regulations, recommend measures to promote social distancing throughout the State. Additionally, on September 22, 2021, Sonoma County Health Officer Dr. Sundari Mase has issued a recommendation to continue online meetings (teleconference meetings) as those meetings promote social distancing, and "present the lowest risk of transmission of SARS-CoV-2, the virus that causes COVID-19." Dr. Mase recommended that if an agency holds in person meetings, a written safety protocol be developed and followed, requiring social distancing and that face masks be worn. Dr. Mase also recommended that for in person meetings, an agency consider holding meetings outdoors to reduce the risk of COVID-19 transmission.

The enclosed resolution makes the necessary findings for the Board, which is subject to the Brown Act, to continue with virtual meetings for the time being. As the Board meets on the

third Thursday of every month, it is possible that more than 30 days may elapse between consecutive meetings. AB 361 is silent as to whether special meetings are required on a more frequent basis to keep up with the 30-day renewal of findings requirement, although scheduling such meetings would ensure strict compliance. Alternatively, if the Board does not meet within thirty days after its prior meeting, the Board should make its renewed findings at the beginning of its next meeting prior to any other action or discussion. Board staff will return to the Board with a resolution every meeting to allow for the continuance of virtual meetings for so long as the Board and staff believes that virtual meetings are necessary.

It is important to that AB 361 does not require Zero Waste Sonoma to continue with virtual meetings, but simply gives the Board that option. If at any time the Board desires to return to in person meetings, the Board can agendize that topic for discussion and direct staff to initiate the transition back to in-person or hybrid meetings. However, at this time, Board staff is recommending adoption of the resolution to allow the Board to continue to be held remotely in order to ensure social distancing consistent with the recommendations of state and local officials.

IV. FUNDING IMPACT

There is no fiscal impact for this item

V. CONCLUSION

Staff recommends that the Board adopt Resolution No. 2022-15, making findings and determinations under AB 361 for the continuation of virtual meetings.

A RESOLUTION OF THE SONOMA COUNTY WASTE MANAGEMENT AGENCY (ALSO KNOWN AS ZERO WASTE SONOMA) MAKING FINDINGS AND DETERMINATIONS UNDER AB 361 FOR CONTINUED VIRTUAL MEETINGS

WHEREAS, the Ralph M. Brown Act (Gov. Code § 54950 *et seq.*) generally requires local agencies meeting via teleconference, including through other virtual or electronic means, to provide public access at each location in which members of the legislative body are teleconferencing; and

WHEREAS, the Legislature recently enacted Assembly Bill 361, Chapter 165, Statutes of 2021 ("AB 361"), which amended Government Code section 54953 to allow local agencies to meet fully virtually during a proclaimed state of emergency if state or local officials have imposed or recommended measures to promote social distancing; and

WHEREAS, the Governor issued a proclamation declaring a state of emergency on March 4, 2020 due to the COVID-19 pandemic, pursuant to section 8625 of the California Emergency Services Act, and this proclaimed state of emergency currently remains in effect; and

WHEREAS, the Board of the Sonoma County Waste Management Agency (also known as Zero Waste Sonoma) has considered the circumstances of the state of emergency; and

WHEREAS, state or local officials continue to recommend measures to promote social distancing; and

WHEREAS, according to the Sonoma County Health Officer, the grounds for the social distancing recommendation include that online meetings (teleconference meetings) "present the lowest risk of transmission of SARS-CoV-2, the virus that causes COVID-19"; and

WHEREAS, the continuation of virtual meetings will allow for full participation by members of the public until social distancing recommendations are lifted; and

WHEREAS, the Board of the Sonoma County Waste Management Agency desires to continue to hold virtual meetings pursuant to AB 361 and Government Code section 54953(e).

NOW THEREFORE, BE IT RESOLVED, the Board of Directors of the Sonoma County Waste Management Agency hereby finds, determines, and resolves as follows:

- 1. The above recitals and true and correct and shall be the findings of the Board of Directors of the Sonoma County Waste Management Agency.
- 2. The Board of Directors the Sonoma County Waste Management Agency shall continue to meet virtually in accordance with Government Code section 54953(e) and without compliance with section 54953(b)(3) based upon the findings and determinations hereby made by the Board.

Recommendation of the Health Officer: Public Meetings

Sonoma County Public Health Recommendations for Safely Holding Public Meetings

September 22, 2021

Each local government agency is authorized to determine whether to hold public meetings in person, online (teleconferencing only), or via a combination of methods. The following are recommendations from Sonoma County Public Health to minimize the risk of COVID-19 transmission during a public meeting of a legislative body held in compliance with Government Code section 54953(e):

- 1. Online meetings (teleconferencing meetings) are strongly recommended as those meetings present the lowest risk of transmission of SARS-CoV-2, the virus that causes COVID-19.
- 2. If a local agency determines to hold in-person meetings, offering the public the opportunity to attend via a call-in option or an internet-based service option is recommended, when possible, to give those at higher risk of and/or higher concern about COVID-19 an alternative to participating in person.
- 3. If a local agency holds in person meetings, a written safety protocol should be developed and followed. It is recommended that the

protocol require social distancing – i.e., six feet of separation between attendees – and face masking of all attendees in compliance with Order of the Health Officer of the County of Sonoma C19-25.

- 4. If a local agency holds in person meetings, seating arrangements should allow for staff and members of the public to easily maintain at least six-foot distance from one another at all practicable times.
- 5. Consider holding public meetings outdoors. Increasing scientific consensus is that outdoor airflow reduces the risk of COVID-19 transmission compared to indoor spaces. Hosting events outdoors also may make it easier to space staff and members of the public at least six feet apart.
- 6. Current evidence is unclear as to the added benefit of temperature checks in addition to symptom checks. We encourage focus on symptom checks as they may screen out individuals with symptoms but no fever and help reinforce the message to not go out in public if you are not feeling well.
- 7. Consider a voluntary attendance sheet with names and contact information to assist in contact tracing of any cases linked to a public meeting.

I. RECOMMENDED ACTION / ALTERNATIVES TO RECOMMENDATION

Staff recommends the Board approve of ZWS's expenditure of \$77,087 for 14,400 organics countertop pails on behalf of the 10 member jurisdictions using SB 1383 Local Assistance Grant funds.

II. BACKGROUND

When regulations for Senate Bill (SB) 1383 Short-lived Climate Pollutants were finalized in 2020, it became evident that implementation would require significant monetary investment. As a result, jurisdictions across the state requested that CalRecycle provide funding assistance. In January 2022, CalRecycle released a non-competitive, one-time grant program that allocated funds to jurisdictions based on their population size. Zero Waste Sonoma staff submitted a regional application on behalf of the 10 member jurisdictions and received a total of \$725,996 in April. Examples of eligible expenses include waste collection infrastructure such as carts and bins, education and outreach, equipment such as vehicles, and personnel.

Countertop pails are currently available from Recology Sonoma Marin (RSM) for their residential customers to pick up upon request. Because the cost of the pails are not included in the franchise agreements, with the exception of Santa Rosa, RSM has a very limited supply. The pails have proven to be very popular with residents, as they are easy to clean and allow for efficient transport of food scraps from the kitchen to outdoor receptacles. Sonoma County Resource Recovery (SCRR) and Sonoma Garbage Collectors do not currently distribute pails to their customers.

Staff from the majority of the member jurisdictions expressed interest in participating in a bulk purchase of organics countertop pails to procure a lower cost per unit. They specifically stated preference for pails with higher recycled content and manufacturing as locally as possible.

III. DISCUSSION

Staff reached out to a number of manufacturers for quotes. Several including EnviroWorld, Oxo, Minky, and Food52 did not respond, but staff did receive the following quotes listed in Table 1.

Although the customer service was still calculating time to delivery, staff ruled out Bamboozle due to its high price per unit. The choice was provided to jurisdictions between Ecovision and SureClose. Jurisdictions preferred SureClose due to its closer manufacturing location and faster time to delivery. SureClose was also the brand of pails that RSM has been distributing, and jurisdictions liked that there would be consistency. A picture of the SureClose pail is below.



During the application for the SB 1383 Local Assistance Grant, each jurisdiction submitted a budget allocating their funds into specific categories. Some jurisdictions chose to allocate more funds to purchasing countertop pails than others.

For the most economical price, Agency staff is requesting one full transfer load of 14,400 units. Healdsburg, Rohnert Park, and Windsor decided not to participate in the bulk purchase, but the allocation of pails for each jurisdiction is listed in Table 2 below. Agency staff have coordinated with RSM to receive the delivery, scheduled for early September. Distribution to each of the jurisdictions will be determined in the coming weeks.

Since this grant was approved after the approval of the FY 22/23 budget, staff is asking the board to approve two budget adjustments. The first will be to complete the purchase of the pails in the current fiscal year and the second will be to increase appropriations in the new fiscal year for full grant implementation.

IV. FUNDING IMPACT

The total price for 14,400 pails is \$70,560, including shipping as well as printing and application of a custom label. State tax will be \$6,527, which brings the total price to \$77,087. There is no impact to the ZWS budget since all expenditures will be paid for through grant funds.

ITEM: FY22/23 Budget Adjustment – CalVolunteers Youth Workforce Development Grant

I. RECOMMENDED ACTION / ALTERNATIVES TO RECOMMENDATION

Staff recommends the Board approve an adjustment to the FY 22/23 Budget, adding \$2,516,260.07 in grant funds from California Volunteers, Office of the Governor, to implement the Youth Workforce Development Program. As this item is an amendment to the budget, it requires a super-majority (8/10) vote for approval.

II. BACKGROUND

On April 15, 2022, Staff received an Award Letter from California Volunteers, Office of the Governor (CalVolunteers) approving Zero Waste Sonoma's application and providing a notice of intent to award \$2,516,260.07 to implement the Youth Workforce Development Program, beginning upon the signing of a contract between ZWS and CalVolunteers.

III. DISCUSSION

When the Board approved the FY 2022/23 budget staff were not aware of the upcoming grant opportunity from CalVolunteers.

Zero Waste Sonoma is partnering with subgrantee Conservation Corps North Bay (CCNB) on this program, with the goal of CCNB providing 84 Program Fellows with training and career development in the fields of food recovery and collection and disposal of hazardous and illegally dumped materials. Fellows will develop programs and services to address two focus areas: food insecurity and climate change.

CCNB will recruit Program Fellows between 16-30 years of age, who may have difficulty finding employment, are low-income, unemployed and/or out of school, and are or were justice-involved. ZWS will provide administrative oversight and regular reporting to CalVolunteers. The grant term begins July 1, 2022 and ends on May 1, 20224.

IV. FUNDING IMPACT

There will be no funding impact to ZWS's budget. All expenditures will be funded through the grant. Staff requests the board approve the increase to budget appropriations for the grant revenue (78110-66111000-42358) in the amount of \$2,516,260.07 and expenditure (78110-66111000-51249) in the amount of \$2,516,260.07.

The attached resolution would give authority to the Executive Director to apply for CalRecycle grants, execute all grant documents, and implement approved grant projects on behalf of ZWS member jurisdictions. The resolution would be effective from June 23, 2022 through June 30, 2026.

IV. FUNDING IMPACT

There is no funding impact as a result of this resolution.

ITEM: Cold Creek Compost Informational Presentation and Discussion

I. RECOMMENDED ACTION / ALTERNATIVES TO RECOMMENDATION

Staff recommends the Board receive a presentation from Cold Creek Compost (CCC) requesting an agreement amendment for receiving and processing Sonoma County's Residential organic material and give direction to staff on how to address CCC's request.

II. BACKGROUND

Zero Waste Sonoma (ZWS) manages the transportation and processing of residential organic material only, which equates to roughly 80,000 tons annually. Additionally, roughly 28,000 tons of commercial organic material is processed through an agreement between the County of Sonoma and Republic Services. ZWS currently contracts with three compost facilities for processing residential organics;

- 1) Waste Management (WM) Earth Care Compost Facility at Redwood Landfill in Novato, which receives residential organic material from Sonoma Transfer Station (STS) and Healdsburg Transfer Station (HTS), Central Transfer Station (CTS), Annapolis Transfer Station (ATS), and Guerneville Transfer Station (GTS).
- 2) Napa Recycling and Compost Facility, which only receives organics material from the STS, and
- 3) CCC, which only receives organic material from HTS.

The below table outlines each facility's tip fee, the hauling fee, the contracted tons of capacity committed to ZWS and the organic material tons received at each facility.

At the May 20, 2021 Board meeting, the Board approved an amendment to the Agency's agreement with CCC for:

- Additional three-year term, to June 30, 2024 with five one-year mutually agreed extensions.
- Five percent increase from their current tip fee (at the time) of \$38.19 which resulted in a current \$41.30 tip fee that went into effect on July 1, 2021. The 5% increase exceeded the original agreement's CPI but staff supported the increase due to adjustments CCC needed to complete for SB 1383 compliance.
- Increased 10,000 tons commitment from 18,000 tons annually to 28,000 tons annually.

III. DISCUSSION

On May 26[,] 2022 and on June 13, 2022 Martin Mileck, Founder, Owner, and President of CCC, sent a letter to the ZWS Board of Directors requesting an agreement amendment to increase the tip fee from \$41.30 to \$66.00 (60% increase) and an increase to our committed material delivery tons from 28,000 tons annually to a minimum of 35,000 – 45,000 tons annually. A \$66 tip fee for processing 35,000 tons of organics is more than \$656,500 greater than what we'd be paying WM Redwood Landfill to process this same tons. Staff does not support CCC's request to increase the tip fee to \$66 for the following reasons:

- The new rate when combined with hauling is well above the current local market rate.
- The Agency has a fiscal responsibility to rate payers and cannot place the burden on ratepayers to meet CCC's requested tip fee to stay in business.
- WM (78,000 tons capacity) and Napa Compost (30,000 tons capacity) organics processing
 agreements have excess capacity committed to ZWS (108,000 tons capacity minus 80,000
 tons composted equals 28,000 tons available of excess capacity).
 - Per the 2021/2022 waste characterization study findings, the following estimated tons of residential organic material is being landfilled:

- C&S Waste Solutions in Ukiah recently opened a new compost facility which is 33 roundtrip miles closer than CCC.
 - o ZWS staff toured the C&S facility on June 21, 2022.
 - The posted tip fee is \$65 per ton.
 - ZWS's tip fee may be less than \$65 if ZWS commits a portion of our organic feedstock tons should both parties enter into negotiations.
- Transportation Green House Gas emissions would decrease by not sending material to CCC (21 miles north east of Ukiah) compared to sending the same material to WM in Novato.

ZWS staff appreciates our working relationship with CCC and it personally saddens staff to not support their proposed agreement amendment. ZWS responded with the best offer to CCC which would equal the current tip fee and hauling fee as WM. CCC responded they simply cannot survive with the counter-offer. CCC requested to present their agreement amendment to the Board and given our long-standing relationship ZWS staff accepted their request.

As you know, California and Sonoma County are in dire need of composting capacity to meet SB 1383 requirements. The typical composting facility requires 5-10 years to permit and construct and costs tens of millions of dollars. Recent regulatory requirements have shuttered composting facilities that are unable to comply with minimum standards. The loss of a fully permitted, zero-discharge facility like Cold Creek Compost is a significant step back for the County's waste diversion goals. We are asking for your help to stay in business.

Our facility opened in 1995 and was the first fully permitted facility in Northern California. In that time, we've composted almost one million tons of organic material diverting over 99 percent of that material from the landfill to create nutrient dense compost used on farms and vineyards in Sonoma County. The operation composts over 50,000 tons per year with the goal to expand to 70,000 tons and has committed 28,000 tons to ZWS annually.

Unfortunately, time is of the essence as the perfect storm of drought, inflation, fuel prices, and impacts to the cannabis industry has exhausted our remaining capital. Without an increase to the facility's tip fee to \$66/ton, we anticipate our facility will cease receiving material by August 2022. We are willing to offer ZWS a long-term contract at \$66/ton with a commitment of 35,000 tons annually and up to 45,000 tons if an expansion is approved. We believe we have been a reliable partner, and a long-term commitment ensures composting capacity for Sonoma County as well as quality organic compost for Sonoma County farmers and growers.

We are open and ready to discuss options with the Board with the goal of keeping the facility operational.

As stated previously, we are seeking a tip fee increase to keep Cold Creek Compost open. We provide the following information for your reference and discussion at the June 23, 2022 ZWS Meeting.

The following table shows pricing and current composting options for Sonoma County as complied by ZWS staff and CalRecycle.



We understand that the Board has a fiduciary responsibility to the ratepayers of Sonoma County. It also has an obligation to meet SB 1383 requirements. The current contracts for organics processing services with Napa Recycling, Waste Management, and Cold Creek are all short term with two years left on the Napa and Cold Creek contracts and three years on the WM contract. While there are additional one-year options, these options are by mutual agreement, thereby not guaranteeing long-term organics processing. As SB 1383 comes online, more jurisdictions will be vying for the same organics processing services driving up prices and locking in capacity.

In 2019, the ZWS task force prepared a needs assessment on meeting the 75 percent requirement for SB 1383. At that time, they estimated an additional 152,000 tons of organics capacity would be needed (See graph below estimating organics tonnage in Sonoma County). It should be noted that while separate from curbside collection, Cold Creek composts thousands of tons of agricultural materials coming out of Sonoma County.





Cold Creek is willing to offer ZWS a guaranteed, long-term contract (5 years or longer) at \$66/ton with a commitment of 35,000 tons annually and up to 45,000 tons if an expansion is approved. At \$66/ton, this is still below market rate for other operations and only \$5 more per ton than Napa's total cost of \$90.

We believe we have been a reliable partner with ZWS, and a commitment to Cold Creek by ZWS ensures long-term composting capacity for Sonoma County. We look forward to the opportunity to continue to support Sonoma County's residential and agricultural communities through organics recycling and providing nutrient dense finished compost.

We look forward to discussing at the June 23, 2022 Board meeting.

The operation composts over 50,000 tons per year with the goal to expand to 70,000 tons and has committed 28,000 tons to ZWS annually.

Unfortunately, time is of the essence as the perfect storm of drought, inflation, fuel prices, and impacts to the cannabis industry has exhausted our remaining capital. Without an increase to the facility's tip fee to \$66/ton, we anticipate our facility will cease receiving material by August 2022. We are willing to offer ZWS a long-term contract at \$66/ton with a commitment of 35,000 tons annually and up to 45,000 tons if an expansion is approved. We believe we have been a reliable partner, and a long-term commitment ensures composting capacity for Sonoma County as well as quality organic compost for Sonoma County farmers and growers.

We are open and ready to discuss options with the Board with the goal of keeping the facility operational.


