Typically, first quarter financial reports do not contain many data points from which to make projections regarding the rest of the fiscal year, but are done to ensure early discrepancies can be addressed throughout the rest of the fiscal year.

Regular Calendar

Discussion and Possible Action on Assignment of Compostable Materials Transport Services and E-Waste Handling Agreements to Recology: The Ratto Group and Recology Sonoma Marin have entered into an asset purchase agreement in which substantially all of the Ratto Group's assets would be purchased by Recology. The SCWMA has two agreements which would be affected by the Ratto Group/Recology agreement: the Organic Materials Transport Services and Electronic Waste Handling Services agreements. The Ratto Group and Recology have requested the SCWMA provide consent to the assignment of those agreements, a requirement of those agreements. SCWMA staff has reviewed the request and performed its due diligence on the assignment. Staff recommends the Board approve the assignment agreement for Compostable Materials Transport Services and E-Waste Handling Services on a supermajority vote, transferring responsibility to perform the tasks and duties in the agreements from the Ratto Group to **Recology Sonoma Marin.**

Ms. Thigpen recommend the Board approve an RFP for the website redesign and implementation.

Board Discussion

Deb Fudge, Town of Windsor, commented on her excitement for the new website. She mentioned her frustration with finding broken links and the order of posting for Agenda items. She inquired about the list of vendors that would be used.

Ms. Thigpen responded that the list of potential vendors would be large.

Henry Mikus, City of Sebastopol, commented that the website redesign is needed due to the lack of accessibility for mobile usage.

Ms. Gorin asked about ongoing administrative costs for the website.

Mr. Carter responded that approximately \$20,000 is allocated to ISD for the existing site. It is anticipated that some of that funding may not be necessary in the future by establishing a site that can be managed by staff internally.

Chairman Sawyer commented that information regarding disposal details are important items for our website. Details on minimums and maximums for household hazardous waste items should be communicated.

Ms. Thigpen reported on the survey for our Recycle Guide. The survey was well responded to on Facebook and answered questions on usage and contained user comments on the guide.

Mr. Carter commented that a full report will happen at a future board meeting on the Recycle Guide feedback. Mr. Carter reported that we have partnered with Goodwill to have mattress recycling at our e-waste events. 149 mattresses were collected an event in Petaluma and 89 mattresses in Santa Rosa. Efforts have begun to look for a northern county HHW site and a consultant to help evaluate the existing facility and look at more options has been hired. The cost is under \$25,000, so was executed under Executive Director signing authority. The compost RFP

deadlines have been extended to accommodate Santa Rosa's need for more time to evaluate their RFP. Question deadline is extended to November 13, 2017 and the deadline for submittal will be moved to January 16, 2018.

ITEM: Legislative Update

I. RECOMMENDED ACTION / ALTERNATIVES TO RECOMMENDATION

This item is informational. No action is required by the Board.

II. BACKGROUND

The 2017/18 California legislative session has adjourned. Governor Jerry Brown has signed several waste related bills into legislation.

III. DISCUSSION

AB 1219 (Eggman) - California Good Samaritan Law

This bill strengthens and expands protection for food donors from legal liability in order to encourage food donations. Currently many businesses, retailers, and restaurants are either not aware of laws which protect food donors or are confused with the current laws in place. The protection is expanded to persons and gleaners who donate food. Notably, the bill also requires health inspectors to promote donation and educate restaurants and grocery stores about these liability protections.

SB 557 (Hernandez) - School Food Donations

This bill allows public school cafeterias to donate unopened prepackaged food, uncut produce (e.g. apples), and properly stored milk to food banks or charitable non-profits. It also makes surplus food available to students during meal time through "share tables" in the cafeteria. This helps communities suffering from food insecurity in addition to reducing edible food waste.

AB 954 (Chiu) - Food Labeling

In an effort to reduce food waste, this bill requires the California Department of Public Health and California Department of Food and Agriculture to publish guidelines that encourage industry adoption of uniform date label standards. Misinterpretation of food date labels is a key factor leading to food waste in American households and supermarkets. This past February, the Grocery Manufacturing Association and Food Marketing Institute launched a voluntary labeling program to limit food labels to two: "BEST IF USED BY" for quality/freshness, and "USE BY" for safety/perishability.

AB 1158 (Chu) - Carpet Recycling

This bill will increase carpet recycling by 50% in two years by requiring a carpet stewardship plan to achieve a 24% recycling rate for post-consumer carpet by January 1, 2020; the bill would authorize CalRecycle to set future recycling benchmarks.

SB 1383 (Lara) - Short Lived Climate Pollutants

SB 1383 creates a framework to reduce the emissions of Short Lived Climate Pollutants, or "Super Pollutants", including methane from the waste sector. This bill was signed into law by Governor Brown September 19th, 2016. The bill grants CalRecycle the authority to adopt regulations to achieve reductions.

Implementing SB 1383 will require the development of a comprehensive organic waste infrastructure statewide, as well as a significant commitment to education and enforcement by local governments & waste haulers. This bill will require a 75 percent reduction in statewide disposal of organic waste by 2025, compared to the amount of organics generated in 2014. It also includes a goal of 20 percent of edible food is to be recovered for human consumption, that is currently disposed of.

SB 1287 (McGuire) - Crab Gear Retrieval Act

This bill promotes the retrieval of lost gear as an easy way to mitigate the increasing amount of ocean waste and wildlife entanglements. This bill is based on successful gear recovery programs in California that have proven effective, have the voluntary support of the fishermen and are self-sustaining.

I. RECOMMENDED ACTION / ALTERNATIVES TO RECOMMENDATION

Staff recommends approving the FY 2017-18 First Quarter Financial Report on the Consent Calendar.

II. BACKGROUND

In accordance with the requirement in the joint powers agreement the Sonoma County Waste Management Agency (SCWMA) staff make quarterly reports to the Board of Directors of Agency operations and of all receipts to and disbursements from the SCWMA, this report covers the First Quarter of FY 17-18 (July 1, 2017 - September 30, 2017).

The FY 2017-18 First Quarter Financial Report contains the actual amounts spent or received to date at the end of the quarter. It is important to not draw many conclusions in the year-to-date figures, as very little of the fiscal year has passed. Second and Third Quarter Reports provide a better picture of the SCWMA's financial position.

III. DISCUSSION

Relatively few revenues have been realized in FY 2017/18 First Quarter. The SCWMA has received two payments of the SCWMA surcharge, the first quarter interest allocations, and few other income sources. Tipping fee/surcharge payments from the County that have not been received yet and are expected to appear on the Second Quarter Financial Report. With regard to expenditures, all accounts are currently projected to stay within budget limits.

IV. RECOMMENDED ACTION / ALTERNATIVES TO RECOMMENDATION

Staff recommends approving the FY 2017-18 First Quarter Financial Report on the Consent Calendar.

ITEM: Discussion and Possible Action on Assignment of Compostable Materials Transport Services and E-Waste Handling Agreements to Recology

I. RECOMMENDED ACTION / ALTERNATIVES TO RECOMMENDATION

Staff recommends the Board approve the assignment agreement for Compostable Materials Transport Services and E-Waste Handling Services on a supermajority vote, transferring responsibility to perform the tasks and duties in the agreements from the Ratto Group to Recology Sonoma Marin.

II. BACKGROUND

The SCWMA currently has agreements with the Ratto Group for hauling and disposal of wood waste and green waste and for the handling of electronic waste (E-waste) delivered to the County-owned transfer stations. The SCWMA originally entered into the organics agreement on September 17, 2014, and subsequently amended that agreement on June 24, 2015 (First Amendment) and November 16, 2016 (Second Amendment). The E-waste agreement was entered into on November 18, 2015 and amended on November 16, 2016 (First Amendment). Both agreements with the Ratto Group will expire on February 11, 2018, unless extended by mutual agreement.

SCWMA staff received a letter from Recology and the Ratto Group, dated September 29, 2017, requesting that the SCWMA consent to a transaction between those two parties where Recology would purchase substantially all of the Ratto Group's assets.

SCWMA staff has participated in an effort led by the City of Petaluma and its contractor, R3 Consulting Group, to perform a regional review of the assignment of agreements from the Ratto Group to Recology. Staff also met with Recology staff and toured the Recology facilities in San Francisco in an effort to determine whether assignment was in the SCWMA's best interest.

III. DISCUSSION

Recology representatives have assured SCWMA staff that they have the equipment and staff necessary to perform the transportation of compostable materials from County-owned transfer stations to SCWMA-directed compost sites. Recology currently handles and consolidates E-waste in its other service territories. SCWMA staff requested one change to the terms and conditions of these agreements: the extension of the termination date from February 11, 2018 to February 11, 2019. SCWMA staff requested the term change to allow SCWMA staff additional time to examine the results of proposals submitted through the organics RFP (proposals are due January 16, 2018),

as the organics system may change significantly with the results of that RFP. Recology requested a 3% cost adjustment to the agreement, as there was no other cost adjustment mechanism in that agreement.

SCWMA staff's assessment of the results of the assignment of this agreement is favorable. As described in the report prepared by R3, Recology's reputation is generally positive as viewed by their municipal partners, as well as their permit compliance history. As it relates to the scope of this agreement and beyond to the SCWMA's education and HHW programs, SCWMA staff has participated in a number of positive discussions with Recology staff and is encouraged by the indicated interest for collaboration on a number of common waste reduction issues that were discussed.

SCWMA staff visited Recology solid waste facilities on October 30 and November 6, and while the facilities are not necessarily comparable to facilities Recology would assume in Sonoma County, staff was impressed by the throughput of those facilities, Recology's commitment to waste reduction and diversion, and Recology's experience with diversion programs. Staff witnessed processes very similar to those required by this compostable material transport and e-waste handling services agreement taking place at the San Francisco facilities, and is confident Recology has the necessary experience to perform the work required should this agreement be assigned to them.

As approval of this item includes extending the term of both agreements an additional year, and involves the committing of SCWMA funding in excess of \$250,000 for that additional year, a supermajority vote is required.

IV. FUNDING IMPACT

Recology has requested a 3% increase to payment for the e-waste agreement, as there was no previous mechanism for cost increases. The increase would be approximately \$1,900, and would not have a significant impact on the HHW fund budget. As such, funding allocated through the SCWMA's FY 2017-18 budget are expected to be sufficient for both agreements.

ASSIGNMENT AND ASSUMPTION AGREEMENT

This Assignment and Assumption Agreement is entered into as of November 15, 2017 by and among the Sonoma County Waste Management Agency, a California joint powers agency ("SCWMA"), The Ratto Group of Companies Inc., a California corporation ("TRG"), and Recology Sonoma Marin, a California corporation ("Recology").

WHEREAS, SCWMA and TRG are parties to the following agreements (the "Agreements"):

- (i) Agreement for Compostable Materials Transport Services dated September 17, 2014, as amended by a First Amendment dated June 24, 2015 and a Second Amendment dated November 16, 2016; and
- (ii) Agreement for E-Waste Handling Services at Sonoma County Disposal Sites dated November 18, 2015, as amended by a First Amendment dated November 16, 2016 (the "E-Waste Agreement");

WHEREAS, TRG and its owners and affiliated entities (collectively, "Ratto") entered into an Asset Purchase Agreement dated August 11, 2017 (the "APA") which provides for the purchase by Recology Inc. or its designated subsidiaries of substantially all of Ratto's assets;

WHEREAS, in connection with the closing of the transactions contemplated by the APA (the "Closing"), TRG wishes to assign the Agreements to Recology, and Recology wishes to accept such assignment;

WHEREAS, each of the Agreements provides that such Agreement may not be assigned by TRG without the prior written consent of SCWMA.

NOW, THEREFORE, the parties agree as follows:

- 1. Subject to and effective as of the Closing, TRG will assign to Recology all of its right, title and interest in and to each Agreement.
- 2. Subject to and effective as of the Closing, Recology will accept such assignment and will assume all duties and obligations of TRG under each Agreement from and after the Closing.
- 3. Recology agrees to notify SCWMA that the Closing has occurred within five (5) business days thereafter.
- 4. SCWMA hereby consents to the foregoing assignment and assumption on the terms and conditions set forth herein.
- 5. Subject to and effective as of the Closing, the Agreements shall be amended (automatically and without any further action by any party) as follows:
 - (i) The term of each Agreement shall be extended by one (1) year, to February 11, 2019, unless earlier terminated in accordance with such Agreement;
 - (ii) Effective as of February 12, 2018, the compensation payable to Contractor under the E-Waste Agreement shall be increased by three percent (3.0%).
